National Provider Identifier (NPI) Technical Instructions

Guidelines for Professional (837P) Claim Submission

837P claim transactions will be accepted when consistent with the HIPAA standards for electronic transactions. HIPAA standards require the use of only the NPI to appropriately identify providers on the claim transaction. Use of Medicaid Provider IDs are not permitted and will result in rejection/denial.

The 837P claims must contain the NPI of the Billing Provider. Taxonomy for the billing NPI may be needed, and is strongly recommended. Refer to the **Billing Provider** components in the table below for details.

If Alaska Medicaid billing rules require identification of the servicing (also called rendering) provider, submit the NPI of the provider who performed the service in the appropriate Servicing Provider Loop identified below. Taxonomy for the servicing NPI may be needed, and is strongly recommended. Refer to the **Servicing Provider** components in the table below for details.

The billing provider's ZIP+4 is the ZIP+4 of your business service location. Submit this information on all of your claims.
