ICD-10 Instructor-Led Training Now Available

Alaska Medicaid is pleased to announce that September 2015 ICD-10 Instructor-Led Provider Training courses are now open for registration. These courses are designed to give providers a general understanding of ICD-10 and the impact it will have once ICD-10 goes into effect on 10/01/2015. You may also log in to the Learning Management System (LMS) at <http://learn.medicaidalaska.com> to view and register for available ICD-10 courses.

Computer-based trainings (CBTs) on ICD-10 are also available on the LMS. Log in to the LMS or create a new account and select ICD-10 from the Provider dropdown menu. There are three CBTs on ICD-10 currently available: "Basic Information", "ICD-10 Impacts and Changes", and "Impacts for Non-Diagnosing Providers". These CBTs include extensive ICD-10 details and examples of how the ICD indicator is used on the CMS-1500 and UB-04 claim forms.

Deadline for ICD-10 Testing Certification Quickly Approaching

The implementation date for ICD-10 is October 1, 2015. Testing is currently in progress. All trading partners must obtain certification to submit ICD-10 claims by September 30, 2015. Trading partners who do not obtain certification will not be able to submit claims after October 1, 2015. Providers should check with their clearinghouse to confirm they obtained certification to submit claims using ICD-10 codes to Alaska Medicaid. Effective Immediately - New Authorization Forms Incorporating ICD-10

Effective August 17, 2015, all service authorization, Certificate of Medical Necessity (CMN), and CMN for Incontinence Supplies requests with dates of service on, after, or spanning October 1, 2015 must incorporate an ICD-10 diagnosis code. The Service Authorization Request form and both types of CMN request forms have been updated to include fields for ICD-10 diagnosis codes. Any requests that are received for dates of service on or after October 1, 2015 that do not include ICD-10 diagnosis codes will be returned to the requester. New ICD-10 Behavioral Health Authorization Request Forms Now Available

New Behavioral Health Service Authorization (SA) Request forms with fields for ICD-10 Diagnosis Codes are now available on the forms page at <http://manuals.medicaidalaska.com/docs/forms.htm>. These new forms are labeled “Effective 10/1/2015 DOS” and must be used when a treatment plan has a begin date on or after October 1, 2015. Continue to use the former versions, labeled “Effective 7/1/12 DOS”, for treatment plans that have begin dates prior to October 1, 2015. Previously approved SAs spanning the October 1, 2015 implementation date will be unaffected.

Durable Medical Equipment Provider Revalidation Required by September 10, 2015

All Durable Medical Equipment (DME) providers are required to revalidate enrollment with Alaska Medicaid. During the week of July 27, 2015, DME providers should have received a letter with additional information regarding revalidation. Revalidation will occur from August 3, 2015 through September 10, 2015. To maintain uninterrupted claims processing and payment, please complete revalidation by September 10, 2015.

Adolescent Health Webcast Series

The leading causes of death and disability in the nation's 42 million adolescents and young adults are largely preventable. Adolescence is one of the most dynamic stages of human development – a time of rapid change and development and a critical time to intervene to promote behaviors that will improve health in the long term.

While generally characterized by good health, adolescence is also a time of dramatic physical, cognitive, social, and emotional change. Often, different challenges first emerge during adolescence. In fact, three out of four adolescents ages 12–19 report engaging in at least one of these activities that risk their overall health: use and abuse of alcohol and other substances, unprotected sex, poor eating and exercise habits, and physically-endangering behaviors.

The U.S. Department of Health and Human Services will present an Education Series focused on increasing the uptake and quality of preventive health services for adolescents. This Education Series addresses successful practices in screening, treatment, and referral of Affordable Care Act-covered preventive services and consists of the following sessions:

Ask Medicaid

Q: I see that the new service authorization (SA) request forms have fields for both ICD-9 and ICD-10 codes. When I submit a claim, do I need to include both ICD-9 and ICD-10 codes as they appear on the SA?

A: No, claims submitted to Alaska Medical Assistance may not contain both ICD-9 and ICD-10 codes. Claims that do not span the October 1, 2015 ICD-10 implementation date should report ICD-9 codes for services rendered on or before September 30, 2015 and ICD-10 codes for services rendered on or after October 1, 2015.

Claims that do span the October 1, 2015 ICD-10 implementation date will generally need to be split into two claims so that all ICD-9 codes remain on one claim with dates of service (DOS) through September 30, 2015 and all ICD-10 codes are on the other claim with DOS on or after October 1, 2015. Certain bill types, predominantly inpatient, have restrictions on splitting claims and must be submitted as a single claim using either ICD-9 or ICD-10 diagnosis codes.
