Reminder: Medical Justification Required for Dental Anesthesia and Sedation

Alaska Medicaid reminds providers that medical justification is required for billing dental codes for general anesthesia and intravenous moderate (conscious) sedation, and that documentation must be submitted with claims for reimbursement. RBRS Service Authorizations Must Now Be Submitted Through Qualis Health

Effective February 1, 2018, all service authorization (SA) requests for group home stays and other residential behavioral rehabilitation services must be submitted through the Qualis Health Provider Portal. Conduent will no longer accept SA requests for these services. Inpatient and residential psychiatric service authorization requests must also be submitted through the Qualis Health Provider Portal. Updated Qualis SA List Effective 02/01/2018

Qualis Health reviews Alaska Medicaid service authorization requests for inpatient stays exceeding three days, certain maternal/newborn admissions, and for inpatient stays and outpatient services related to selected diagnoses and procedures identified on the *Qualis Select Diagnoses and Procedures Pre-Certification List*. The list has been updated and is in effect for services rendered on and after February 1, 2018.

CMS NCCI MUE Update – A9901 Guidance

Effective October 1, 2017, the Centers for Medicare and Medicaid Services (CMS) published a National Correct Coding Initiative (NCCI) Medically Unnecessary Edit (MUE) update reducing the allowed units for code A9901 from one unit to zero units.

As a result of this change, Alaska Medicaid will no longer reimburse claim lines submitted with code A9901. Until further notice, DME service delivery and dispensing expenses (7 AAC 120.200) may be submitted to Alaska Medicaid using HCPCS code A9999.

Claims must conform to all state and federal regulations and rules to be eligible for payment. Providers seeking reimbursement for delivery and dispensing services are responsible for appropriate claims submission.

New Presumptive and Definitive Drug Screening/Testing Limits Effective 01/01/2018

Alaska Medicaid has implemented new limits to presumptive and definitive drug testing effective January 1, 2018. Provider billing manuals have been updated to reflect these changes. Rate Changes for Genetic Testing

Alaska Medicaid utilizes the Medicare Clinical Laboratory Fee Schedule to set rates for covered laboratory procedures. The Centers for Medicare and Medicaid Services' newly established rates for the following codes will be effective for Alaska Medicaid services provided on and after February 11, 2018.

81220 (CFTR Gene Common Variant):	\$556.60
81243 (FMR1 Gene Detection):	\$57.04
81228 (Cytogenomic Microarray):	\$900.00
81229 (Cytogenomic Microarray):	\$1,160.00
81404 (Molecular Pathology Level 5):	\$274.83
81405 (Molecular Pathology Level 6):	\$301.35
81507 (Fetal Aneuploidy Trisomy Risk):	\$795.00

New Limits on Federal Financial Participation for DME

Effective January 1, 2018, federal Medicaid reimbursement shall not exceed certain aggregate limits for durable medical equipment (DME). This federal change applies to durable medical equipment covered by Medicaid that are also Medicare covered items. Dental SA Requests Must Be Completed in Full

Alaska Medicaid reminds providers that authorization requests for dental services must be completed in full, including the date of service. If the request is for a retroactive date of service, check “yes” in field #2 and enter the retroactive date of service in field #4. If the request is for the current or a future date, check “no” in field #2 and enter the planned date of service in field #4. Incomplete or incorrect authorization requests will be returned without an authorization decision.
