



## National Provider Identifier (NPI) Instructional Document for Billing Group Services

The billing rules listed below apply to the professional claim form (CMS-1500 paper form and 837P electronic format). They impact the following provider type groups:

- Care Coordination Agencies: CMG####
- Podiatry Groups: PDG###
- Medical Professional Groups: MPG####, MDG### and GR####
- Psychology Groups: PSG#####
- Therapy Center Groups: TC##### and GR####
- Respiratory Therapy Services billed by Durable Medical Equipment providers: MS####
- Chiropractic Groups: CHG###
- Physician Groups: GR#### and MDG###
- Private Duty Nursing Agencies: NA####
- Vision Groups: VG####

## Billing Guidelines for Group Practices Submitting Claims on the CMS-1500 Claim Form

### Paper Claim Billing Guidelines for Group Practices billing with NPI only:

- The National Provider Identifier (NPI) for the *rendering provider performing the service* must be submitted in field 24J of the CMS-1500 claim form. If submitted, the corresponding taxonomy for the rendering provider is entered in the shaded line in field 24J with the ZZ qualifier in field 24I. The rendering provider must be enrolled with Alaska Medicaid and must have furnished their NPI in their enrollment packet. The NPI in field 24J, and the taxonomy, if provided, must match the NPI and taxonomy included in their enrollment packet.

In the example above, NPI 1234567890 belongs to Dr. Jones. Taxonomy code 207V00000X is the taxonomy code that describes Dr. Jones' specialty. This matches the taxonomy code reported with the NPI in Dr. Jones' enrollment packet.

- The billing group must submit the Group Practice NPI in field 33A of the CMS-1500 claim form (see A in below example). Field 33A information is used in determining the *Pay-to Provider* for claims billed with only the NPI. If submitted, the corresponding taxonomy must be in field 33B with the ZZ qualifier (see B in below example). Providers must submit the *address with full ZIP+4 postal code* for the physical location of the group practice in field 32 (see C in below example).

In the example above, NPI 9876543210 belongs to Dr. Jones' Professional Corporation, a group practice. Taxonomy code 193400000X describes Dr. Jones' Professional Corporation. Note: The ZZ qualifier value immediately precedes the taxonomy code. The ZIP code in field 32 identifies the physical location of the group practice. This information was reported in Dr. Jones' enrollment packet.

## Billing Guidelines for Group Practices Submitting Claims in the Professional (837P) Format

The 837P claims must contain the Billing NPI in the **Billing Provider Loop 2010AA**. The rendering/servicing provider NPI is in the **Rendering Provider Loop 2310** when all services on the claim were performed by the **same** provider. Use **Rendering Provider Loop 2420** when the services on the claim were performed by more than one provider. Rendering provider is also called servicing or performing provider. Required fields and values are as follows:

***Alaska Medicaid enrollment records must include the rendering providers within a group practice. To avoid claim denial, Medicaid provider records must show the rendering provider as a member of the group practice for the claim date of service. It is the responsibility of the group practice to keep their practice membership records current.***
