During the COVID-19 public health emergency, the COVID-19 vaccine will be covered with no co-pay requirement or out-of-pocket costs for members. * Since we anticipate that providers, initially, will not incur a cost for the COVID-19 vaccine products (i.e., “free”), providers should not submit the vaccine product code on claims billed using the professional claim format (e.g., 837P, CMS-1500).

For Pharmacies billing for COVID-19 vaccine services using the NCPDP format, submit the following

- [436-E1] Product/Service ID Qualifier = 03, National Drug Code
- [407-D7] Product/Service ID = National Drug Code for vaccine product
- [409-D9] Ingredient Cost Submitted = \$0.01, when vaccine product provided free of charge
- [438-E3] Incentive Fee Submitted = Administration Fee, correlating to 0001A, 0002A, 0011A, 0012A, 0021A, or 0022A
